EXECUTIVE SUMMARY

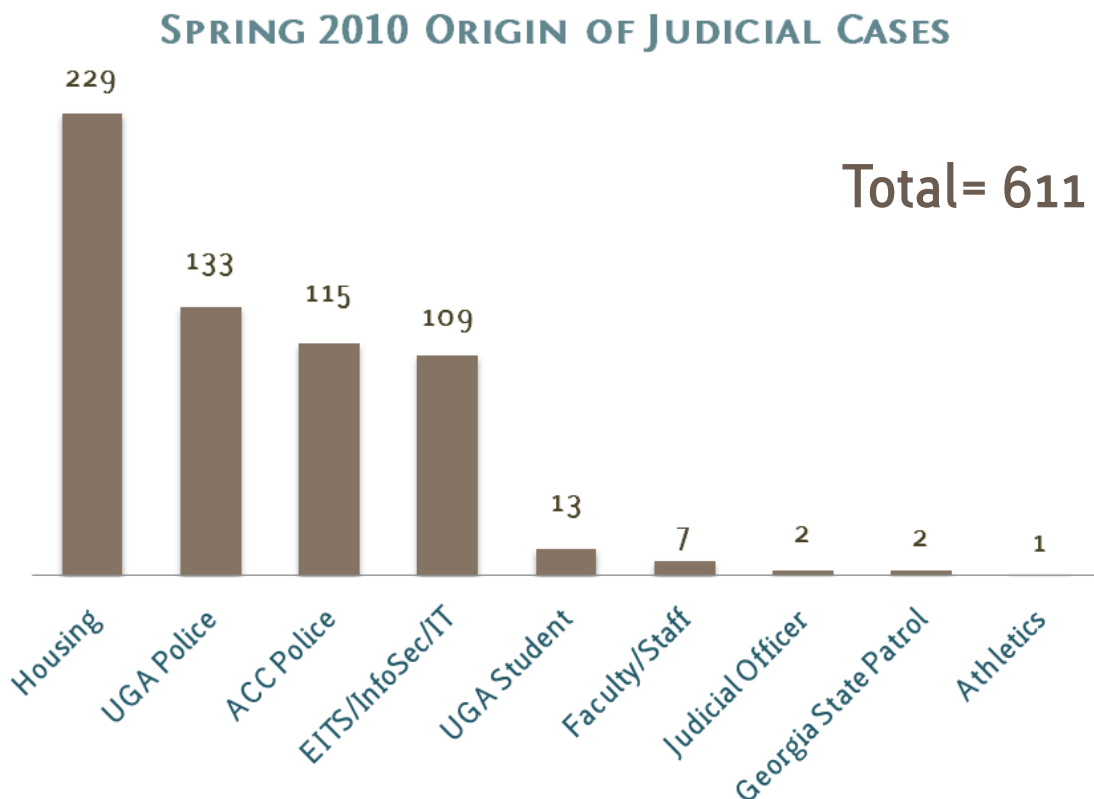
The data within this report reflects cases with incident dates from January 1, 2010 through May 31, 2010. This report provides an overview of cases resulting from alleged violations of the University of Georgia (UGA) Code of Conduct. While the majority of cases were managed by the Office of Judicial Programs (OJP), University Housing data is also included. The following are highlights from the report.

- OJP received 611 cases spring semester 2010. The majority of cases originated from Housing, UGA Police Department, Athens Clarke County Police, and University Computer Services (EITS/InfoSec).
- OJP resolved 427 cases as compared to 140 resolved through the Department of Housing.
- University hearing officers resolved 71% (n=423) of the cases informally, while students elected to resolve cases through the formal hearing process at a rate of 7% (n=43).
- There were a total of 1,056 alleged violations during the spring semester.
- Males (n=356) were more likely than females (n=207) to face allegations of violations.
- Related to alcohol and other drugs, freshmen make up the majority of students allegedly violating the Code of Conduct related to Regulation 4, at a rate of 68% (n=323).
- The most common assigned sanction was University probation (284), followed closely by mandated alcohol education classes (n=256) through the Fontaine Center or a court-approved facility.
- During the spring semester, 27 students were suspended from the University.
 - 3.2 (n=1), 3.3 (n=1), 3.6 (n=6), 4.1 (n=25), 4.2 (n=1), 4.3 (n=5), 4.4 (n=2), 5.2 (n=1), 9.2 (n=7), 13.6 (n=1), and 14.4 (n=1) were the violations resulting in suspension.
 - n=26 under the minimum sanctions policy, n=1 under the new Alcohol and Other Drug Policy.
- There were a total of five appeals for the spring 2010 semester.
- OJP notified the parents or guardians of 228 students under the age of 21 that their students were found to have violated Code of Conduct policies on the use or possession of alcohol or other drugs.
- There were a total of 25 repeat violators during the spring 2010 semester, with males (n=18) more likely to come through the process again than females (n=7).
- OJP processed 2,603 Dean's Certifications.

SPRING 2010 CASE ORIGINATION

“Incidents of alleged violations of conduct regulations are reported to the Associate Dean of Students for Judicial Programs, Office of Judicial Programs (500 Memorial Hall) or a designee. Individuals or groups filing a report should do so in writing and the report should be submitted as soon as possible after the alleged violation. Reports not submitted in writing will be independently verified prior to beginning a judicial investigation. For individuals filing a report, a meeting can be arranged with a staff member in the Office of Judicial Programs to discuss the judicial process. For incidents to be reported in University Housing, individuals or groups filing a report may contact the Area Office where the incident took place” (The University of Georgia Code of Conduct, 2010).

OJP receives reports of alleged violations of conduct regulations from a variety of sources. Unless suspension or expulsion are possible sanctions, incidents reported by University Housing personnel are often heard by University Housing staff. Housing and the UGA Police Department provided the majority of reports to OJP for the spring 2010 semester.

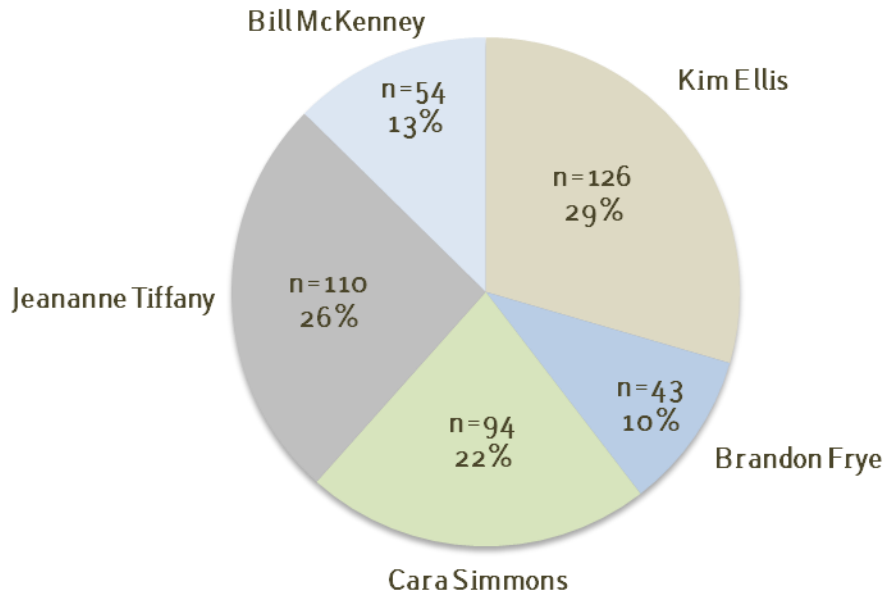


SPRING 2010 HEARING OFFICER

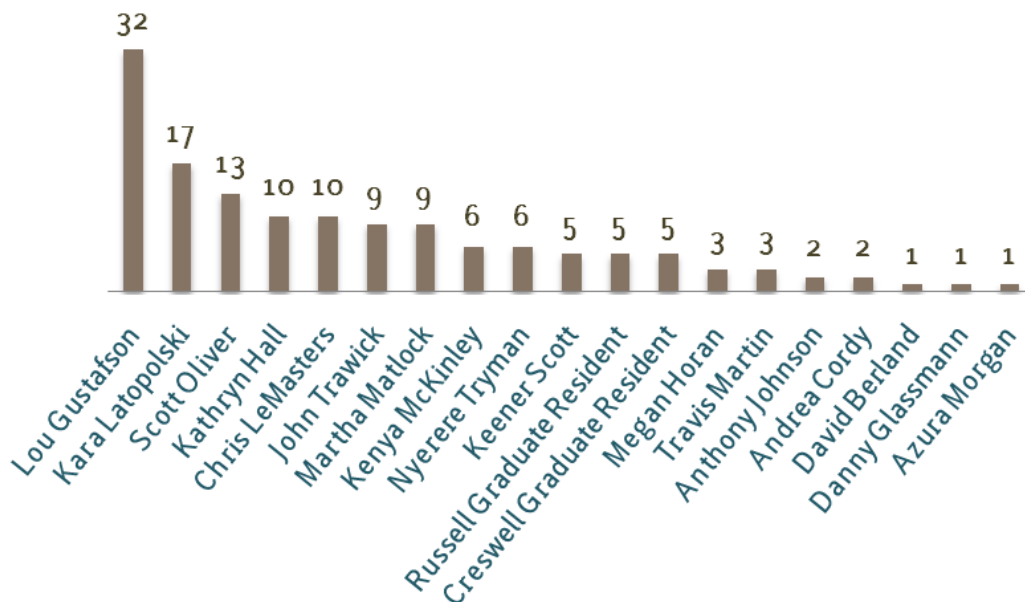

Total= 427



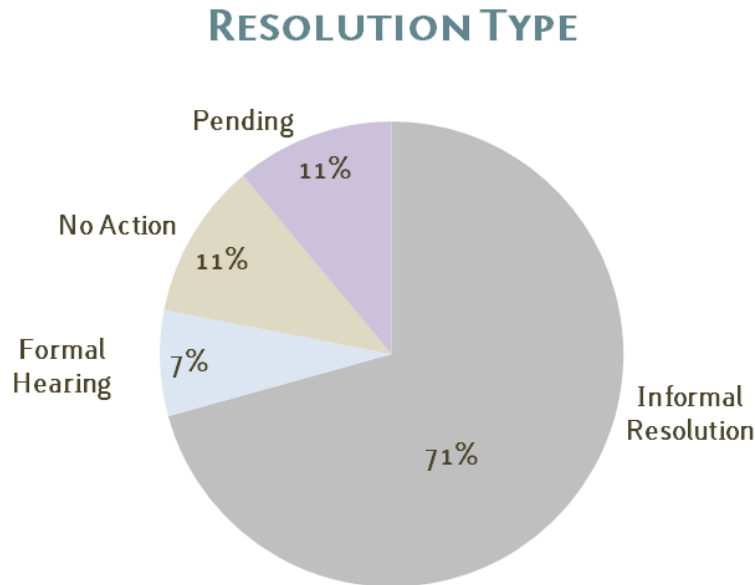
RESIDENCE LIFE AND HOUSING

SPRING 2010 ANALYSIS OF RESOLUTION

“During the meeting the staff member will determine which, if any, of the alleged charges are to be resolved through the judicial process and advise the student or organization about the options for resolving judicial charges. There are two available options from which the student or organization can choose: (1) informal resolution, or (2) formal resolution (hearing)” (The University of Georgia Code of Conduct, 2010).

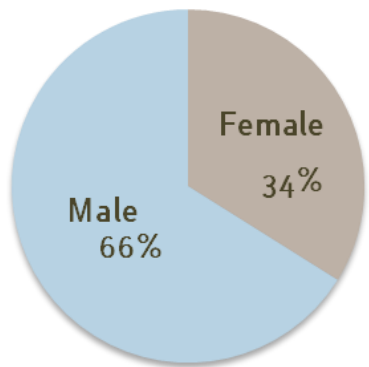

SPRING 2010 ANALYSIS BY GENDER

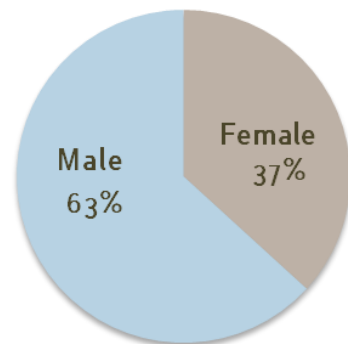

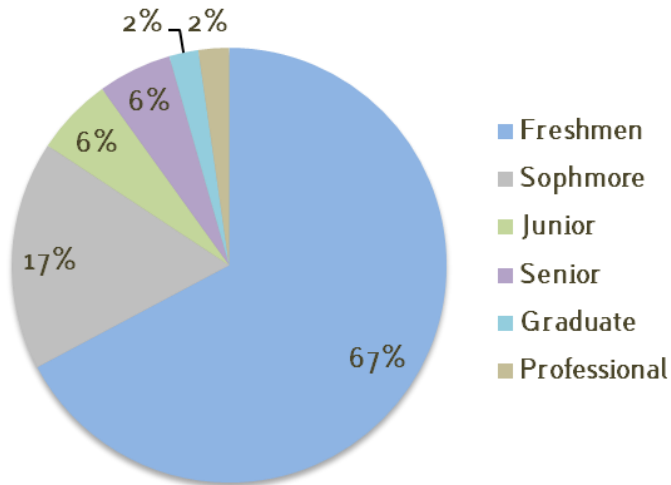

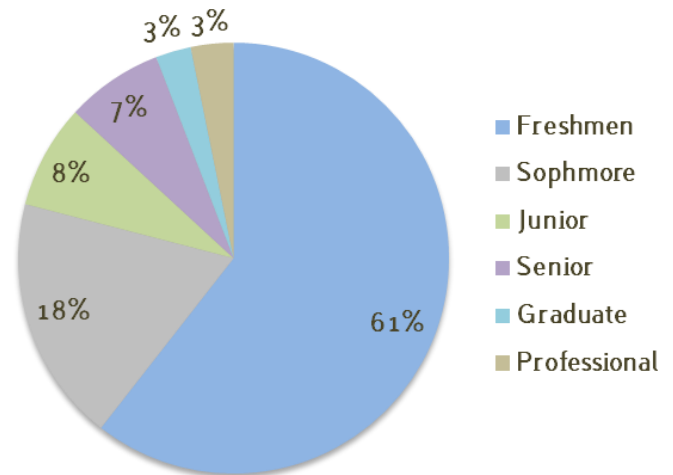

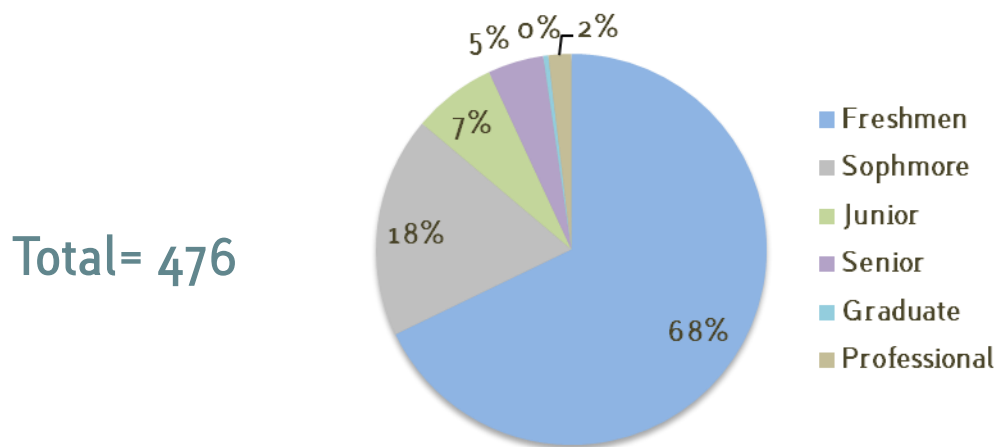

ALCOHOL AND OTHER DRUG ALLEGED VIOLATIONS BY CLASSIFICATION



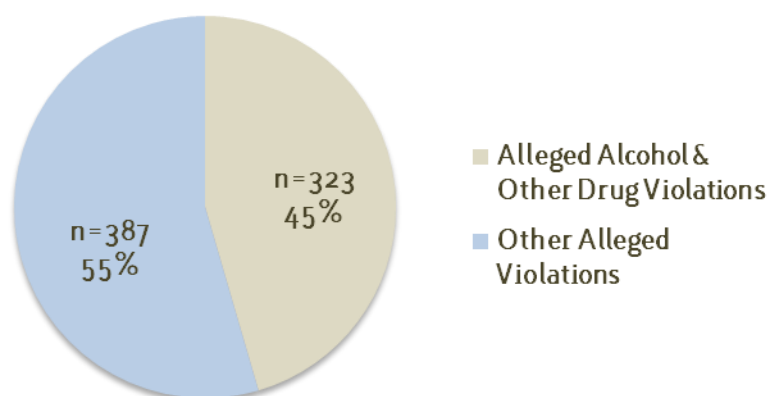

TYPE OF VIOLATIONS FOR FRESHMEN



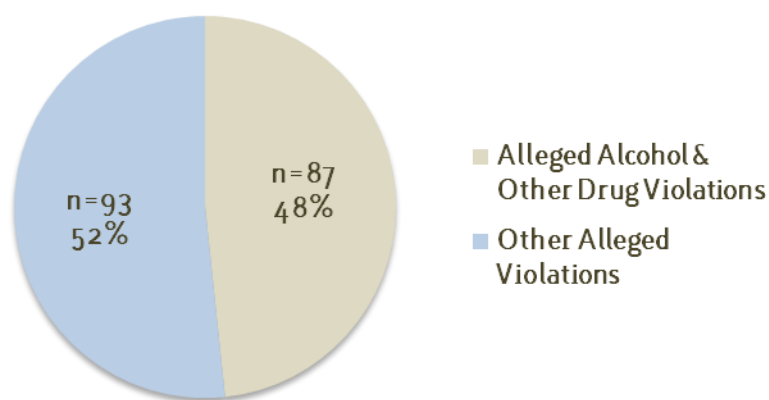

TYPE OF VIOLATIONS FOR SOPHOMORES



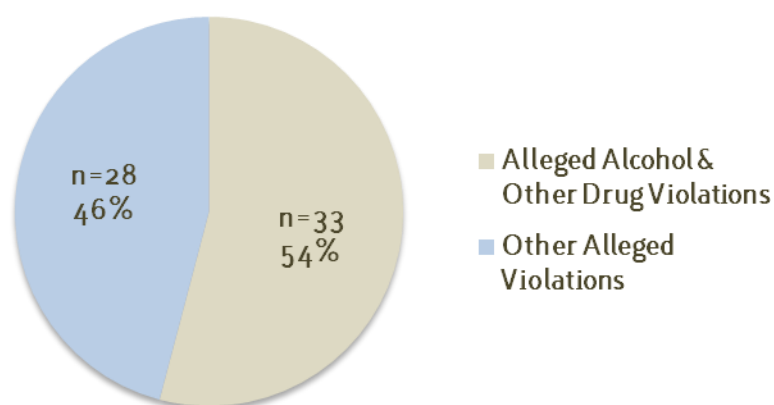

TYPE OF VIOLATIONS FOR JUNIORS



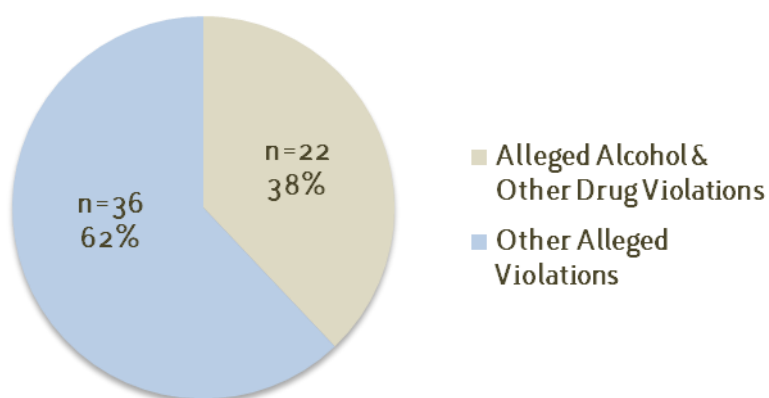

TYPE OF VIOLATIONS FOR SENIORS



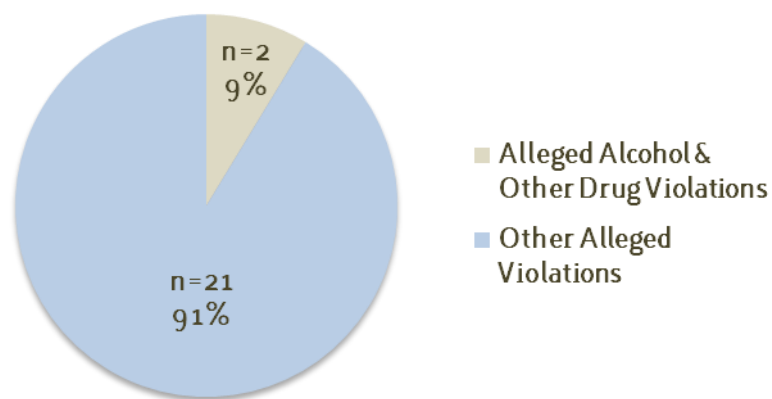

TYPE OF VIOLATIONS FOR GRADUATES



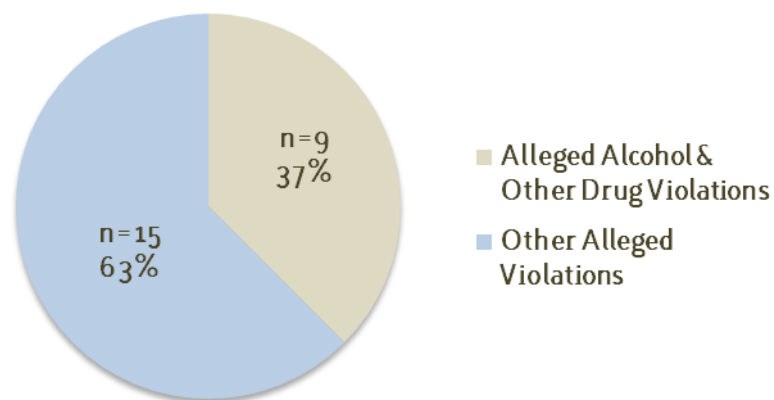

TYPE OF VIOLATIONS FOR PROFESSIONALS

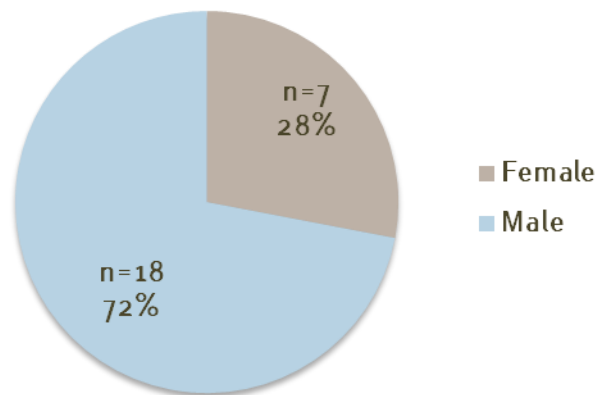

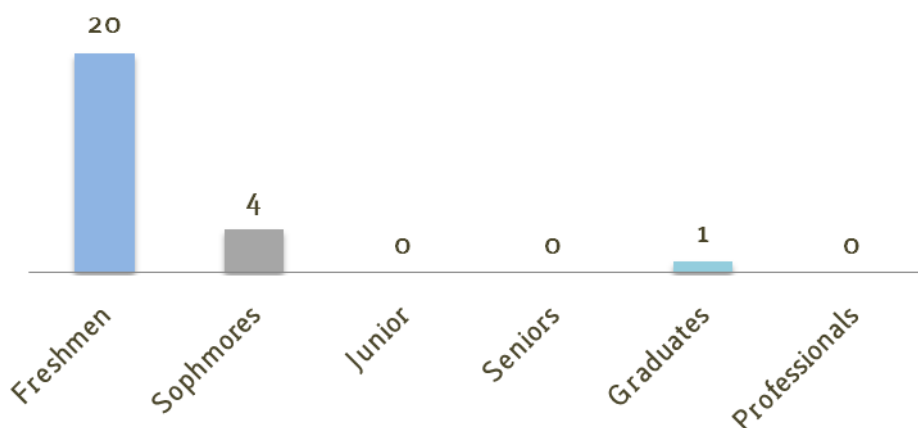

SPRING 2010 APPEALS

“The student or organization may appeal the decision from a formal judicial hearing. Appeal information will be included with the decision issued to a student or organization. Appeal forms are available in OJP. All appeals must be in writing and submitted to OJP within five (5) University business days of receipt of the decision. The purpose of appeal procedures is to provide the student with the opportunity to bring forward questions regarding substantive or procedural errors that occurred during the process. The appeal process is not intended to grant a new hearing at a higher level. Dissatisfaction with a decision is not grounds for an appeal” (The University of Georgia Code of Conduct, 2010).
