

Introduction

This report provides an overview of cases resulting from alleged violations of the University of Georgia (UGA) Code of Conduct. The data within this report reflects incidents referred as alleged violations of the Code of Conduct between the dates of January 1, 2011 and May 15, 2011. *In past years, the spring reporting dates have included January 1 through May 31.* Reporting dates were changed for spring 2011 to coincide with the end of the academic semester, which also marked the last effective date of the 2010-11 Code of Conduct.

It is important to note that the numbers contained in this report only reflect those cases *referred* during the reporting period. Except where noted, the report does not include data for cases that were referred prior to January 1, 2011 and resolved after January 1, 2011.


The following are highlights from the report.

- The majority of the 507 cases referred in spring 2011 originated from University Housing, Athens Clarke County Police, University Computer Services (EITS/InfoSec), and UGA Police.
- Of the 507 cases, 367 were assigned to be resolved by conduct officers in the OSC while 140 were assigned to be resolved by conduct officers in University Housing.
- Conduct officers resolved 461 of the 507 cases, with 76% (n=386) resolved informally and 4% (n=22) resolved through the formal hearing process. Conduct officers did not find sufficient information to move forward with 53 of the referred cases (11%), and the remaining 9% (n=46) remained under investigation at the time this report was generated.
- Some of the cases reported contained multiple alleged violations, resulting in a total of 902 alleged violations of the Code of Conduct during the spring semester.
- Over 60% of all alleged violations related to alcohol or other drugs involved freshmen (30%) and sophomore students (32%).
- A total of 481 students, including 302 males and 179 females, were alleged to have violated the Code of Conduct in spring 2011. Of those 481 students, 21 were alleged to have been involved in more than one incident. In addition, three student organizations were referred during the spring semester.
- The most commonly assigned sanction for violation of the Code of Conduct was University probation (n=232), followed closely by mandated alcohol or other drug (AOD) education classes (n=213).
- Thirteen students referred for conduct violations in spring 2011 were suspended from the University.
 - O The regulations violated in cases that resulted in suspension include: 2.2 (n=3), 3.2 (n=1), 3.3 (n=1), 3.6 (n=3), 4.1(n=11), 4.3 (n=5), 4.4(n=5), 4.5 (n=3), 5.1 (n=1).
 - o Five of the students were on probation at time of suspension.
 - An additional 6 students, whose cases were referred to the OSC prior to January 1, 2011, were suspended from the University during spring 2011.
- There were a total of three appeals during spring 2011. One of these appeals was for a case that was referred prior to January 1, 2011.
- The OSC sent 163 parental notifications to the parents or guardians of students under the age of 21 that
 were found to have violated Code of Conduct regulations related to the use or possession of alcohol or
 other drugs.

Spring 2011 Case Origination

"Incidents of alleged violations of conduct regulations are reported to the Director for Student Conduct, Office of Student Conduct (500 Memorial Hall) or a designee. Individuals or groups filing a report should do so in writing and the report should be submitted as soon as possible after the alleged violation. Reports not submitted in writing will be independently verified prior to beginning a judicial investigation. For individuals filing a report, a meeting can be arranged with a staff member in the Office of Student Conduct to discuss the judicial process. For incidents to be reported in University Housing, individuals or groups filing a report may contact the Area Office where the incident took place" (The University of Georgia Code of Conduct, 2010).


Reports of alleged violations of the Code of Conduct are referred from a variety of sources. Incidents reported by University Housing are adjudicated by University Housing conduct officers unless the case involved a level two violation of regulation 4 or the sanctions assigned to the case include suspension or expulsion; under those circumstances, the case is adjudicated by a conduct officer in the OSC. University Housing and Athens Clarke County Police provided the majority of referrals in spring 2011.




Spring 2011 Case Assignments

"After receiving a report, a staff member will be assigned to investigate the circumstances of the incident and determine what conduct regulations, if any, are alleged to have been violated" (The University of Georgia Code of Conduct, 2010).


Office of Student Conduct Total = 367





Spring 2011 Analysis of Resolution

"During the meeting the staff member will determine which, if any, of the alleged charges are to be resolved through the judicial process and advise the student or organization about the options for resolving judicial charges. There are two available options from which the student or organization can choose: (1) informal resolution, or (2) formal resolution (hearing)" (The University of Georgia Code of Conduct, 2010). In the event that the conduct officer (after conducting an investigation) does not find sufficient information to move forward with a case, it is resolved as a "no action" case. *Pending cases are those still under investigation at the time this report was generated*.

Spring 2011 Total Alleged Violations

The data reflects all alleged violations of the Code of Conduct based on reported incidents. Many incidents include multiple alleged regulation violations; therefore, a difference exists between the number of incidents and number of violations. Additionally, some students were involved in more than one incident, resulting in a difference between number of incidents and number of students and organizations involved.





Gender Analysis of Number of Students/Organizations Involved





Classification Analysis of Number of Alleged Violations


Classification Analysis of Number of Students Involved

Percentage of Alleged Regulation Violation Types by Gender/Organization





Spring 2011 Recidivism



Spring 2011 Sanctioning

When it has been determined that a student or organization has violated a University conduct regulation, the conduct officer or hearing panel will assign one or more sanctions. The findings of fact, any particular circumstances, and prior record of the student or organization will be the factors considered when determining any appropriate sanctions (modified from The University of Georgia Code of Conduct, 2010).

Spring 2011 Appeals

"The student or organization may appeal the decision from a formal judicial hearing. Appeal information will be included with the decision issued to a student or organization. Appeal forms are available in the Office of Student Conduct. All appeals must be in writing and submitted to the Office of Student Conduct within five (5) University business days of receipt of the decision. The purpose of appeal procedures is to provide the student with the opportunity to bring forward questions regarding substantive or procedural errors that occurred during the process. The appeal process is not intended to grant a new hearing at a higher level. Dissatisfaction with a decision is not grounds for an appeal" (The University of Georgia Code of Conduct, 2010).

Spring 2011 Parental Notifications

"The Family Educational Rights and Privacy Act (FERPA) has given colleges/ universities the option to notify parents or guardians about specific types of information from a student's judicial record" (The University of Georgia Code of Conduct, 2010).

"The Office of Student Conduct will notify parents or guardians the first time and every subsequent time a student is found to have violated Code of Conduct policies on the use or possession of alcohol or other drugs when he/she is under the age of 21" (The University of Georgia Code of Conduct, 2010).
