EXECUTIVE SUMMARY

The data within this report reflects cases with incident dates from June 1, 2010 through July 31, 2010. This report provides an overview of cases resulting from alleged violations of the University of Georgia (UGA) Code of Conduct. Please note, data for graduate and professional students was not available for the summer 2010 semester and is not included in this report. The following are highlights from the report.

- OJP received 76 cases during summer semester 2010. The majority of cases originated from Athens Clarke County Police and UGA Police Department.
- OJP resolved all 76 cases.
- University conduct officers resolved 50% (n=38) of the cases informally, while students elected to resolve cases through the formal resolution process at a rate of 1% (n=1), with 45% (n=34) of cases pending.
- There were a total of 102 alleged violations during the summer semester.
- Males (n=50) were more likely than females (n=26) to face allegations of violations.
- Related to alcohol and other drugs (AOD), sophomores make up the majority of students allegedly violating the Code of Conduct related to Regulation 4, at a rate of 48% (n=31). Seniors did not have any alleged violations of Regulation 4.

-AOD pending cases (n=25) have yet to be classified as level I or level II


- The most common assigned sanction was University probation (n=29), followed closely by mandated alcohol education classes (n=25) through the Fontaine Center or a court-approved facility.
- No students were suspended from the University with incident dates during the summer semester.
- OJP notified the parents or guardians of 45 students under the age of 21 that their students were found to have violated Code of Conduct policies on the use or possession of alcohol or other drugs.
- There were no repeat violators during the summer 2010 semester.
- OJP processed 382 Dean's Certifications.

SUMMER 2010 CASE ORIGINATION

"Incidents of alleged violations of conduct regulations are reported to the Associate Dean of Students for Judicial Programs, Office of Judicial Programs (500 Memorial Hall) or a designee. Individuals or groups filing a report should do so in writing and the report should be submitted as soon as possible after the alleged violation. Reports not submitted in writing will be independently verified prior to beginning a judicial investigation. For individuals filing a report, a meeting can be arranged with a staff member in the Office of Judicial Programs to discuss the judicial process. For incidents to be reported in University Housing, individuals or groups filing a report may contact the Area Office where the incident took place" (The University of Georgia Code of Conduct, 2010).

OJP receives reports of alleged violations of conduct regulations from a variety of sources. Unless suspension or expulsion are possible sanctions, incidents reported by University Housing personnel are often heard by University Housing staff. ACC Police and the UGA Police Department provided the majority of reports to OJP for the summer 2010 semester.

SUMMER 2010 ORIGIN OF JUDICIAL CASES





SUMMER 2010 ANALYSIS OF RESOLUTION

"During the meeting the staff member will determine which, if any, of the alleged charges are to be resolved through the judicial process and advise the student or organization about the options for resolving judicial charges. There are two available options from which the student or organization can choose: (1) informal resolution, or (2) formal resolution (hearing) " (The University of Georgia Code of Conduct, 2010).











Type of Violations for Freshmen





SUMMER 2010 PARENTAL NOTIFICATIONS

"The Family Educational Rights and Privacy Act (FERPA) has given colleges/ universities the option to notify parents or guardians about specific types of information from a student's judicial record" (The University of Georgia Code of Conduct, 2010).

The Office of Judicial Programs will notify parents or guardians the first time and every subsequent time a student <u>is found to have violated</u> Code of Conduct policies on the use or possession of alcohol or other drugs when he/she is under the age of 21" (The University of Georgia Code of Conduct, 2010).

The following numbers are based on the date the Parental Notification was sent (June 1, 2010–July 31, 2010), not based on the date of the incident.
